City of Goshen Tax Discount

The City Commission is pleased to announce your discounted tax rate is 10%. Please note to receive this discount your City taxes must be paid by September 1, 2021. Taxes paid between September 1–30, 2021 are the face amount. A 10% penalty will be applied to all unpaid bills after September 30th. The City Budget for the fiscal year of July 1, 2021 - June 30, 2022 will reflect \$80,320 in property tax revenue for the City. The City Tax rate has been set at 13.1 cents per \$100 assessed property value. The City has established the following procedure in order for your taxes to be processed in a timely manner. We hope you will take advantage of this discount. Taxes will be sent to the homeowner's address on August 1st. It is the homeowner's responsibility to forward the tax information to your mortgage company.

*Please note many mortgage companies have brokered out tax bills to a 3rd party tax service to pay homeowner taxes. Please contact your mortgage company and make sure you have the correct information before you forward your tax bill to be paid. Please contact the City Clerk at 228-2377 if you have not received an invoice by July 6 or if you have question regarding your tax bill.

Street Parking

No junked or abandoned vehicles (including vehicles with expired license plate or vehicles which are non-functional). 91.23

On-street parking and yard parking are prohibited except during (i) inclement weather or (ii) driveway repair work or (iii) periodic gatherings, BUT any permitted on-street parking shall not restrict the safe passage of emergency vehicles or otherwise cause the existence of unsafe conditions. 70.20. (County Ordinance prohibits street parking during inclement weather. Vehicles will be towed at owner expense.)

AN ORDINANCE PROVIDING FOR THE ASSESSMENT OF ALL REAL PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF GOSHEN KENTUCKY, AND FOR THE LEVY AND COLLECTION OF AD VALOREM TAXES THEREON TO BE USED FOR GENERAL CITY PURPOSES DURING THE FISCAL YEAR OF JULY 1, 2021 TO JUNE 30, 2022.

BE IT ORDAINED BY THE CITY OF GOSHEN, KENTUCKY:

SECTION 1: The following provisions for the assessment, levy and collection of taxes shall apply for the fiscal year of July 1, 2021, through June 30, 2022 for the City of Goshen, Kentucky.

SECTION 2: There is levied for the fiscal year July 1, 2021 through June 30, 2022, a tax at a rate of .131% that will yield \$80,320 in tax revenue based on the assessed values as published by the Oldham County Property Valuation Administrator.

SECTION 3: The City of Goshen, Kentucky, hereby elects to use the annual assessment of the Property Valuation Administrator of Oldham County, Kentucky, as the basis for all ad-valorem taxes on real property and improvements. The Homestead and Disability Exemption as authorized by Section 170 of the Kentucky Constitution is hereby adopted.

SECTION 4: Pursuant to its authority under the provisions of KRS 82.082 and 91A.510, there is levied upon all real property for the fiscal year July 1, 2021 through June 30, 2022, a storm water user fee levied at the rate set by the City Commission in the City of Goshen Stormwater User Fee Policy, which fee is based upon the impervious surface area of each property. The fees collected will be used to pay for the City of Goshen's compliance with the Clean Water Act and MS4 permitting and compliance, in accordance with the City's storm water permitting ordinances.

SECTION 5: All taxes assessed on real property within the City of Goshen pursuant to this Ordinance shall become due and payable on September 30, 2021. If paid before September 1, 2021 the taxpayer shall have a discount of ten percent (10%) of the tax bill. All tax payments made after September 30, 2021, shall be considered delinquent and a penalty of ten percent (10%) shall be charged, plus an interest charge of one percent (1%) of the payment due shall be assessed on the subsequent month for which such payment is due and owing.

SECTION 6: The City Clerk/Treasurer, Mayor, City Attorney or such other person as may from time to time be duly authorized by the Mayor or Commission of the City of Goshen is hereby authorized and directed at his/her discretion, to use any method provided by law to collect the tax assessed by the Ordinance. Such methods may include but not limited to, garnishment and the filing and foreclosure of a tax lien.

SECTION 7: Where any lien is filed pursuant to this Ordinance, then in accordance with KRS 134.420, the fee for filing and releasing the lien shall be paid to the Oldham County Clerk by the City of Goshen and shall become part of the lien as an added cost to the delinquent taxpayer to be paid by him as part of the amount necessary to release the lien.

SECTION 8: Any unpaid tax, as herein provided, shall remain a lien against the property in favor of the City of Goshen, until fully paid.

SECTION 9: Proceeds of such taxes are to be placed in the general fund of the City of Goshen, Kentucky, and are to be used for general operating purposes and expenses of the City in accordance with the fiscal year 2021-2022 budget, and for any and all necessary and proper municipal function as may be properly ordained or resolved by the City Commission.

SECTION 10: This Ordinance shall be effective upon publication.

AN ORDINANCE ADOPTING THE CITY OF GOSHEN, KENTUCKY, ANNUAL BUDGET FOR THE FISCAL YEAR JULY 1, 2021 THROUGH JUNE 30, 2022.

WHEREAS, an annual budget proposal and message have been prepared and delivered to the legislative body; and WHEREAS, the legislative body has reviewed such budget proposal and made necessary modifications, NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF GOSHEN, KENTUCKY:

SECTION 1: The annual budget for the fiscal year beginning July 1, 2021 and ending June 30, 2022 is hereby adopted as follows:

2021 Grand Marshall

Master Sargent Griffin is a Veteran of three wars, World War II, Korea, and Vietnam. He is among a very rare and elite group of service members who has three combat infantry badge awards. This service alone would make him an excellent honoree as this year's Grand Marshall, but in addition he also received a Purple Heart for combat wounds in all three conflicts. There are many distinguished Veterans living in Oldham County, but there is not to my knowledge any other person who so unambiguously deserves the moniker "Hero".

If you could ignore Master Sargent Griffin's heroic actions that occurred so long ago, you should not overlook his continued devotion to Oldham County. At the age of 92, remains a servant to the people. He unassumingly works around the County with youth and adult to ensure younger Veterans are not forgotten. Master Sargent Griffin has personally donated many thousands of dollars to Oldham County charities. He is always ready to offer an encouraging word, and is an inspiration to all who know him.

Always the third Saturday in July

Oldham County Day is the brainchild of the late Nancy Crass, a Project Guild member and longtime La Grange resident. The event began in 1971 and now boasts more than 120 booths, live music and a vibrant parade filled with hometown pride. Proceeds from booth space fuel Project Guild's year-round commitment to community support.

We start the week with our Grand Marshal Luncheon at The John Black Center the Tuesday before Oldham County Day.

Watch the parade in Downtown LaGrange near the Courthouse Square on Saturday morning (Be sure to have a spot picked out and ready to go as it starts at 10:00am). The parade route may look a little different this year as we try to work around the construction on the Square Anticipate seeing the Grand Marshall, local school marching bands, tractors, horses, fire trucks, church, local business and other group floats that match the parade's theme for the year. Kids are also invited to decorate their bikes and ride in the parade! Check out the booths in Downtown La Grange. Many of the booths feature local businesses and organizations in the Oldham County area. Meet local politicians, learn more about locally owned businesses, churches, maybe get a freebie or enter a raffle! Food and drinks are will be available. In the past, a lot of the booths had kid-friendly giveaways (like Dairy Queen ice cream coupons), bounce houses and balloon artists and visitors saw living statues. It's definitely worth checking out Main Street and surrounding attractions after the parade!

There is a lot of entertainment planned before and after the parade. Listen to music while you're at the festival. There is a great lineup of various artists. Head to LaGrange Christian Church for children's activities.

Enjoy a pancake breakfast on Saturday morning at the LaGrange Community Center on Jefferson Street 7-10:30am. There is a cost for the breakfast but it goes to support the LaGrange Rotary Club.

Arrive early for parking! Southeast Christian Church has generously donated a bus making the rounds from their lot up to the festivities.
